Second: Participation Terms

- Applicants must hold at least a Bachelor's Degree in a subject related to human rights (Such as law, political science, international relations, or other relevant disciplines), or is expected to graduate soon.
- The applicant should be familiar with the principles of scientific research.
- Commitment to personal presence at the NIHR's headquarter throughout the fellowship program period, or to participate through video communication programs whenever the need arises.
- Full knowledge of national legislation, regional conventions, international instruments on human rights, and relevant United Nations bodies.
- Submit a research paper at the end of the fellowship period (1000 words minimum) in Arabic or English.
- Comply with the regulations and decisions related to the regulation of attendance and departure, and the health requirements issued by the General Secretariat.

Third: Required supporting documents

- A letter explaining why you wish to join the fellowship program. with an explanation if the applicant is still a student (specifying the name of the academic institution) or working in a government or private sector (specifying the name of the entity) or not working.
- A letter of approval from the employer or the university in which he/she studies - as the case may be, explaining the approval of participation and personal attendance at the NIHR's headquarters.
- Curriculum Vitae (CV) detailing qualifications and previous work experience.
- The title of the research that the researcher wishes to present (please choose one of the following human rights topics, or another topic):
 - The impact of pandemics and diseases on the national economy and entrepreneurship.
 - Achieving equal treatment and gender equality in all rights..
 - Others
- A copy of the academic degree (approved and certified by the concerned authorities) or a letter from the academic authority that he is still working to obtain it..
- Copy of your ID card or passport.
- Enjoying the right to education, and mechanisms for spreading human rights culture.
- Enjoying the highest attainable standard of health.
